**INTERNATIONAL STUDENT APPLICATIONS TO THE PHD PROGRAMS FOR THE ACADEMIC
YEAR 2015-2016 (FALL SEMESTER)**

1. Application period starts on July 6, 2016. **Deadline is August 14, 2015.**
2. Candidates are required to apply through online application system on the link below

- **Please read carefully the Application Guide before entering the online application system.**
- **Candidates who submit their applications will be notified of status of their applicaitons.**

3. Application documents for the MA Programs

- a) Turkish or English translation of undergraduate and Master's Degree (with thesis) diploma.
- b) Turkish or English translation of undergraduate and Master's Degree (with thesis) transcript and the document regarding the lecture contents.
- c) A copy of the score reports of one of the valid ALES, GRE or GMAT Tests (Applicants who do not have a score report of ALES/GRE/GMAT can enroll by taking conditional acceptance. In this situation, they sign a written contract stating that they will fulfill their pre-enrollment liabilities within one year after submitting their Turkish language certificate).
- d) Copy of valid diploma (Bachelor and Master (with thesis) Degrees) of equivalence by The Council of Higher Education for diplomas received from Foreign Country higher education institutions, (registered students on the basis of conditional acceptance are allowed one semester to submit this document).
- e) Documents related to the Turkish Language Proficiency of the candidates who apply to the programs in Turkish:
 - In case of application to a Turkish program – prospective students need to prove that they have sufficient Turkish knowledge to follow courses. B2 or upper level of

exam result is needed to be submitted (Minimum B2 TÖMER, UTS or other equivalent valid Turkish test results are accepted).

- If students do not have any Turkish Language Certificate /Score Reports, they will have conditional acceptance and they are allowed one year to submit this document before starting to the courses. After one year if students cannot submit a valid Turkish Language Certificate /Score Reports, they will also get one more additional year to take a valid score report. When additional year ends, if they still cannot submit the Certificate/Score Report, their registration is cancelled.
 - If students completed their high school/undergraduate/master's d degree in Turkish, they do not need to submit any Turkish test result.
- f) In addition to the Turkish Language Certificate, documents related to the English Language Proficiency of the candidates:
- A score report of YDS/UDS/KPDS Tests (English) : 60 or equivalent of TOEFL IBT 72, CAE: C, CPE:C and PEARSON PTE: 55 score reports must be submitted
- g) 2 colored passport size photos (should have been taken in the last six months).
- h) Copy of the passport pages showing credentials

4. List of the PhD Programs offered in Istanbul Commerce University

- Candidates are allowed to make max. three choices of programs (two from the same graduate school, one from a different graduate school). The applications to three different programs at the same time are considered invalid.
